**ABSTRACT:** Collection contains records of the Vice President of Academic Affairs from St. John's University. The Vice President of Academic Affairs was the chief academic officer of the university, a role now fulfilled for both the College of Sant Benedict and St. John's University by the Provost. Most of the records date from 1972-1995.

**SCOPE AND CONTENT NOTE:** The collection includes minutes, correspondence, reports, and financial records. A significant portion of the collection is related to accreditation. Other topics include St. John's as a Catholic university, faculty, academic departments, academic programs that extend beyond one department or division, and relations with other institutions.
