**ABSTRACT:** Records of the Campus Planning and Design Committee (CPDC). Formerly called the Design Committee, this group became the Corporate Design Committee in 2001. The current name was adopted in 2012. This advisory committee makes recommendations to St. John's Abbey and St. John's University pertaining to new construction, renovation of facilities, landscaping, signage, and the aesthetics of shared spaces.

**SCOPE AND CONTENT NOTE:** The collection comprises print materials originating from the Campus Planning and Design Committee. It includes agenda and minutes. It also includes attachments to the minutes such as architectural drawings, presentations, and correspondence.

Frequent topics include interior design, building renovation, landscaping, lighting, signs, and memorials. The committee sometimes considers matters that have environmental as well as aesthetic aspects.

St. John's University Archives holds most of the CPDC materials, and Corporate Design Committee minutes from 2007 to 2012, in electronic format as well as in print. As of October 2018, University Archives no longer creates printed copies of CPDC materials received only in digital format.

**ADMINISTRATIVE HISTORY:** "Sensitivity to and concern for aesthetic and stewardship issues led University President Michael Blecker, O.S.B., to establish a design committee in the early 1970s as a standing university committee. Over the years, it developed into an advisory board for all of the divisions of the Order of Saint Benedict: Saint John's Abbey, Saint John's Preparatory School, Saint John's University, and Liturgical Press." -- Declaration of Covenants, Conditions, Restrictions and Easements for Order of St. Benedict (d/b/a Order of Saint Benedict) and Saint John's University, Collegeville, Minnesota 7.1(c), July 2012.

The Design Committee was renamed the Corporate Design Committee in 2001, the corporation being the Order of St. Benedict, Inc. St. John's University was a division of the Order of St. Benedict, and ultimately under the administration of the Abbot of St. John's Abbey. When St. John's University was separately incorporated in July 2012, the group became a joint committee of the Order of St. Benedict and St. John's University, and adopted the name of Campus Planning and Design Committee.

**ARRANGEMENT:** The files are organized chronologically.

**ACCESS RESTRICTIONS:** There are no access restrictions on the materials, and the collection is open to all members of the public.

Accession 2012-029 was deposited in the Archives on September 7, 2012. Accession 2016-018 was transferred to the Archives beginning July 9, 2015. Accession 2018-016 was transferred to the Archives beginning August 15, 2018. Accession 2020-013 was transferred to the Archives beginning October 12, 2019.

Accessions 2012-028 and 2012-029 are print surrogates of materials received electronically, and were processed by Elizabeth T. Knuth on February 23, 2021. Accession 2016-018 was processed by Molly Heller in 2016, by Matthew Genereau in
